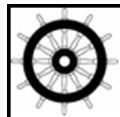

## Product description

"A1 IMO"

Is gel-coated glass reinforced product made of:

- gel coat: two-component material consisting of mineral powder and water borne acrylic resin, with 1 mm thick, and density of 1.75 kg/ltr and off-white colour.
- resin: two-component material consisting of mineral powder and water borne acrylic resin, with density 1.75 kg/ltr.
- Glass reinforcement: glass fabric, weight per unit area per layer 160g/m<sup>2</sup>.

Total thickness: 4 mm

Weight per unit area: 7.5 kg/m<sup>2</sup>

## Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on non-combustible substrate with a greater thickness than 12 mm.

Approved colour: off white

Organic content: 9%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Maximum gross calorific value shall be documented separately where applicable, ref. SOLAS Chapter II-2 Reg. 5.3.2.

Each product is to be supplied with its manual for installation, use and maintenance.
